A) Vice President:

- Must have been a member of MOS of good standing for a minimum period of 7 years.
- Must have held an organizational position as an office bearer for a minimum period of one term for that post and attended at least four managing committee meetings in one year.
- Must have actively participated in the scientific and organizational activities of the society.
- Should have served as Joint Secretary & Secretary, or Joint Treasurer & Treasurer or Chairman Scientific committee of MOS

B) Joint Secretary / Joint Treasurer

- Must have been a member of good standing of the society for 5 years.
- Must have been a member of the managing committee for at least one term and attended at least 4 managing committee meetings in 1 term.
- Should have attended at least two annual conferences of the society and actively participated in scientific/organizational activities of the society.

C) Zonal Member

- Must have been a member of good standing of the society for at least 3 years.
- Must have attended at least two annual conferences of the society
- Should have actively participated in scientific / organizational activities of the society.

Tenure

All members of the managing committee representing the various zones and all office bearers are eligible for re-election only once to the same office so that they can serve a maximum of two terms only. President, 1stVice-President, 2nd vice-president and MOS representative to AIOS are not eligible for re-election.
