Eligibility for contesting various posts:

1. No Member of Local Organizing Committee (LOC) will be able to contest in that election. The LOC will include the Organizing Chairman, Organizing Secretary, Joint-Secretary, Treasurer, Joint-Treasurer and Chairman Scientific Committee of Local Organizing Committee. LOC also includes the President, Vice President, Secretary, Treasurer and Scientific Committee Chairman of host Society.
2. Past President will not contest any for post except for MOS Representatives to AIOS.
3. Member shall not hold or contest more than one office unless proposed by the managing committee as an additional charge.
4. No one should contest any post unless he completes his/her tenure of the post in the coming Annual General Body meeting if he is holding any post in the MOS office.
5. The contesting member should be a resident of Maharashtra as per constitution *Article-V (1) (d)*

A) Vice President:

- a) Must have been a member of MOS of good standing for a minimum period of 7 years.
- b) Must have held an organizational position as an office bearer for a minimum period of one term for that post and attended at least four managing committee meetings in one year.
- c) Must have actively participated in the scientific and organizational activities of the Society.

B) Joint Secretary/ Joint Treasurer:

- a) Must have been a member of good standing of the society for 5 years.
- b) Must have been a member of the managing committee for at least one term and attended at least 4 managing committee meetings in 1 term.
- c) Should have attended at least two annual conferences of the Society and actively participated in scientific/organizational activities of the Society.

C) Chairman Scientific Committee:

- a) Should have been a member of the Scientific Committee for at least one term.
- b) Should have attended at least 5 MOS conferences and have had presentations in at least 3 Annual conferences.
- c) Should have been a member of good standing of the Society for at least 7 years.

D) Chief Editor JCOR:

- a) Should have been a member of the Scientific Committee for at least one term.
- b) Should have attended at least 5 MOS conferences and have had presentations in at least 3 Annual conferences.
- c) Should have been a member of good standing of the Society for at least 7 years.
- d) The person should have published at least 5 articles in Peer reviewed journals
- e) Should have served as reviewer in a peer reviewed journal and at least reviewed 5 articles.
- f) Should have attended at least one research methodology workshop

F) Members of Scientific Committee:

- They should have attended at least 3 Annual conferences of MOS and must have had presentations in at least 1 Annual conference.
- Must have been a member of good standing of the Society for at least 3 years

Tenure:

All members of the managing committee representing the various zones and all office bearers are eligible for re-election only once to the same office so that they can serve a maximum of two terms only. President, 1st Vice-President, 2nd Vice-President and MOS representative to AIOS are not eligible for re-election.
